 - Bid opening shall be on February 4, 2019 at 9:00 A.M. at the City Mayor's Conference Room, 2nd Floor City Hall, Carig, Tuguegarao City. Bids will be opened in the presence of the Bidders' Representatives, who choose to attend at the address below. Late bids shall not be accepted.
