INVITATION TO BID

REPAIR OF BARANGAY GYMNASIUM ANNAFUNAN EAST, TUGUEGARAO CITY

1. The City Government of Tuguegarao, through the Aid to Barangay for Calendar Year 2019, intends to apply the sum of **Two Million Two Hundred Thousand Pesos (Php2,200,000.00)**, being the Approved Budget for the Contract (ABC) to payments for the Infrastructure Project: **Repair of Barangay Gymnasium, Annafunan East, Tuguegarao City** under **PB-INF-2019-040**. **Bids received in excess of the ABC shall be automatically rejected at the bid opening.**
2. The City Government of Tuguegarao now invites bids for the above-captioned Infrastructure Project. Completion of Work is required within Ninety (90) Calendar Days from the issuance of the Notice To Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction To Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “Pass/Fail” criterion as specified in the **2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184**, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino Citizens/Sole Proprietorships, Cooperatives, and Partnerships or Organizational with at least Seventy Five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the City Government of Tuguegarao and inspect the Bidding Documents at the address given below during office hours (from 8:00 A.M. to 5:00 P.M. Monday to Fridays).

5. A complete set of Bidding Documents may be purchased by interested Bidders on February 28, 2019 until March 21, 2019 from the address below and upon payment of a non-refundable fee of **Five Thousand Pesos (Php5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the non-refundable fee for the Bidding Documents, not later than the submission of their bids.

6. The City Government of Tuguegarao, through its Bids and Awards Committee will hold a Pre-Bid Conference on March 8, 2019, 10:00 A.M., at the City Mayor's Conference Room, 2nd Floor City Hall, Carig, Tuguegarao City, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before 8:00 A.M. of March 21, 2019. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause18.

Bid opening shall be on March 21, 2019 at 9:00 A.M. at the City Mayor's Conference Room, 2nd Floor City Hall, Carig, Tuguegarao City. Bids will be opened in the presence of the Bidders' Representatives, who choose to attend at the address below. Late bids shall not be accepted.

8. The City Government of Tuguegarao reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
