Bidding is restricted to Filipino Citizens/Sole Proprietorships, Cooperatives, and Partnerships or Organizational with at least Seventy Five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Bid opening shall be on February 10, 2022 at 10:00 A.M. at the City Mayor's Conference Room, 2nd Floor City Hall, Carig, Tuguegarao City. Bids will be opened in the presence of the Bidders' Representatives, who choose to attend at the address below. Late bids shall not be accepted.
