CONSTRUCTION OF SIDEWALK WITH REHABILITATION OF MASONRY DRAINAGE STRUCTURE (PHASE I) AT LUNA ST. TOWARDS MABINI ST. AND MABINI ST. TOWARDS LECAROS ST., CENTRO 2, 3 & 4, TUGUEGARAO CITY

1. The City Government of Tuguegarao, through the **20% Economic Development Fund for C.Y. 2024** as approved by the Sangguniang Panglungsod, intends to apply the total sum of **Ten Million One Hundred Thousand Four Hundred Twenty Pesos (Php10,100,420.)**, being the Approved Budget of the Contract (ABC) to payments for the **Infrastructure Project: CONSTRUCTION OF SIDEWALK WITH REHABILITATION OF MASONRY DRAINAGE STRUCTURE (PHASE I) AT LUNA ST. TOWARDS MABINI ST. AND MABINI ST. TOWARDS LECAROS ST., CENTRO 2, 3 & 4, TUGUEGARAO CITY** under Project ID No. **PB-INF-2024-043**. Bids received in excess of the ABC shall be automatically rejected at the bid opening.
2. The City Government of Tuguegarao now invites bids for the above-captioned Infrastructure Project. Completion of Work is required within **Two Hundred Ten (210) Calendar Days** from the issuance of the **Notice To Proceed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction To Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary “Pass/Fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. Bidding is restricted to Filipino Citizens/Sole Proprietorships, Cooperatives, and Partnerships or Organizational with at least Seventy Five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the City Government of Tuguegarao and inspect the Bidding Documents at the address given below during office hours (from 8:00 A.M. to 5:00 PM Mondays to Fridays).
5. A complete set of Bidding Documents may be purchased by interested Bidders on **March 19, 2024 until April 08, 2024** from the BAC Office 4th Floor City Hall Bldg., Carig,

Tuguegarao City and upon payment of a non-refundable fee of **Twenty Five Thousand Pesos (Php25,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the nonrefundable fee for the Bidding Documents, not later than the submission of their bids.

6. The City Government of Tuguegarao, through its Bids and Awards Committee will hold a **Pre-Bid Conference on March 26, 2024 at 10:00 AM**, at the City General Services Office, which shall be open to prospective bidders.
7. **Bids must be duly received by the BAC Secretariat at the City General Services Office not later than 08:00 AM of April 08, 2024.** All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause18.

Bid opening shall be on April 08, 2024 at 08:00 AM at the City General Services Office. Bids will be opened in the presence of the Bidders' Representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The City Government of Tuguegarao reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
