 - Bidding is restricted to Filipino Citizens/Sole Proprietorships, Cooperatives, and Partnerships or Organizational with at least Seventy Five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from the City Government of Tuguegarao and inspect the Bidding Documents at the address given below during office hours (from 8:00 A.M. to 5:00 P:M. Monday to Fridays).
- 5. A complete set of Bidding Documents may be purchased by interested Bidders on April 12, 2021 until May 3, 2021 from the address below and upon payment of a non-refundable fee of **Five Thousand Pesos (Php5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the non-refundable fee for the Bidding Documents, not later than the submission of their bids.

- 6. The City Government of Tuguegarao, through its Bids and Awards Committee will hold a Pre-Bid Conference on April 20, 2021, 10:00 A.M., at the City Mayor's Conference Room, 2nd Floor City Hall, Carig, Tuguegarao City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before 9:00 A.M. of May 3, 2021. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on May 3, 2021, 2021 at 10:00 A.M. at the City Mayor's Conference Room, 2nd Floor City Hall, Carig, Tuguegarao City. Bids will be opened in the presence of the Bidders' Representatives, who choose to attend at the address below. Late bids shall not be accepted.
