CONTRACT

THIS AGREEMENT made this ____ day of October 2021 between the *City Government of Tuguegarao* (hereinafter called "the Entity") of the one part; and *AVES FARM SUPPLY AND GENERAL MDSE.* (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., PROCUREMENT OF HYBRID YELLOW CORN SEED (GMO) (City Hall, Carig Sur, Tuguegarao City) in PB-G-2021-024 and has accepted a Bid by the Supplier for the supply of said goods and services at a price equivalent Two Million Six Hundred Ninety Six Thousand Two Hundred Pesos. (₱2,696,200.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - A. the Bid Form and the Price Schedule submitted by the Bidder;
 - B. the Schedule of Requirements;
 - C. the Technical Specifications;
 - D. the General Conditions of Contract;
 - E. the Special Conditions of Contract; and
 - F. the Entity's Notification of Award.
- 3. In consideration of the payments to be made by the **Entity** to the **Supplier** as hereinafter mentioned, the **Supplier hereby covenants with the Entity** to provide the goods and services and to remedy defects therein in conformity and in all respects with the provisions of the Contract.
- 4. The **Entity** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and services and the remedying of defects therein, the **Contract Price** or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
