INVITATION TO BID

PROCUREMENT OF HYBRID YELLOW CORN SEED (GMO)

1. The City Government of Tuguegarao, through the 2021 LDRRMF Agricultural and Livestock Rehabilitation Program (Rehabilitation and Recovery), intends to apply the total sum of **Three Million Four Hundred Ninety Eight Thousand Eight Hundred Eighty Pesos (Php3,498,880.00)** to payments for the Procurement Project: **Procurement of Hybrid Yellow Corn Seed (GMO)** under *PB No. G-2021-026*. **Bids received in excess of the ABC shall be automatically rejected at bid opening.**
2. The City Government of Tuguegarao now invites bids for the above captioned Procurement Project. Delivery of the Goods is required within Thirty (30) Calendar Days from the issuance of the Notice To Proceed. Bidders should have completed, within the past five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction To Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "Pass/Fail" criterion as specified in the **2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184**, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested suppliers, whether local or foreign, subject to the conditions for eligibility provided in the said IRR of R.A. 9184.
4. Interested bidders may obtain further information from the City Government of Tuguegarao and inspect the Bidding Documents at the address below during office hours (from 8:00 A.M. to 5:00 P.M. Mondays to Fridays).
5. A complete set of Bidding Documents may be acquired by interested Bidders on November 1, 2021 until November 22, 2021 from the address below and upon payment of the applicable fee of **Five Thousand Pesos (Php5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the non-refundable fee for the Bidding Documents, not later than the submission of their bids.

6. The City Government of Tuguegarao, through its Bids and Awards Committee will hold a Pre-Bid Conference at 10:00 A.M. of November 9, 2021 at the City Mayor's Conference Room, 2nd Floor City Hall, Carig, Tuguegarao City, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before 9:00 A.M. of November 22, 2021 (The deadline for the submission and receipt of bids). All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on November 22, 2021 at 10:00 A.M. at the Mayor's Conference Room, 2nd Floor City Hall, Carig, Tuguegarao City. Bids will be opened in the presence of the Bidders' Representatives, who choose to attend at the address below. **Late bids shall not be accepted.**

8. The City Government of Tuguegarao reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of R.A. 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
