

CONTRACT

THIS AGREEMENT made this ____ day of February 2022 between the *City Government of Tuguegarao* (hereinafter called “the Entity”) of the one part; and *NORTHEASTERN METAL CRAFT AND TRADING* (hereinafter called “the Supplier”) of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **PROCUREMENT OF ONE (1) UNIT UTILITY VEHICLE** in **PB-G-2022-003** and has accepted a Bid by the Supplier for the supply of said goods and services at a price equivalent **Two Million Five Hundred Ninety Thousand Pesos (₱2,590,000.00)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - A. the Bid Form and the Price Schedule submitted by the Bidder;
 - B. the Schedule of Requirements;
 - C. the Technical Specifications;
 - D. the General Conditions of Contract;
 - E. the Special Conditions of Contract; and
 - F. the Entity’s Notification of Award.
3. In consideration of the payments to be made by the **Entity** to the **Supplier** as hereinafter mentioned, the **Supplier hereby covenants with the Entity** to provide the goods and services and to remedy defects therein in conformity and in all respects with the provisions of the Contract.
4. The **Entity** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and services and the remedying of defects therein, the **Contract Price** or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS WHEREOF the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
