Bidding is open to all interested suppliers, whether local or foreign, subject to the conditions for eligibility provided in the said IRR of R.A. 9184.
- 4. Interested bidders may obtain further information from the City Government of Tuguegarao and inspect the Bidding Documents at the address below during office hours (from 8:00 A.M. to 5:00 P.M. Mondays to Fridays).
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on March 18, 2021 until April 8, 2021 from the address below and upon payment of the applicable fee of **Five Thousand Pesos (Php5,000.00).**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the non-refundable fee for the Bidding Documents, not later than the submission of their bids.

- 6. The City Government of Tuguegarao, through its Bids and Awards Committee will hold a Pre-Bid Conference at 10:00 A.M. of March 26, 2021 at the City Mayor's Conference Room, 2<sup>nd</sup> Floor City Hall, Carig, Tuguegarao City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before 9:00 A.M. of April 8, 2021 (The deadline for the submission and receipt of bids). Bid opening shall be on April 8, 2021 at 10:00 A.M. at the Mayor's Conference Room, 2<sup>nd</sup> Floor City Hall, Carig, Tuguegarao City. Bids will be opened in the presence of the Bidders' Representatives, who choose to attend at the address below. **Late bids shall not be accepted.**
