### APPROPRIATION ORDINANCE NO. 02-2013

### AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 02 OF TUGUEGARAO CITY FOR CY 2013

WHEREAS, Section 458 of Republic Act 7160, otherwise known as the Local Government Code of 1991 and Article 99 (2) (i) of the Rules and Regulations Implementing the Local Government Code of 1991, provides that the Sangguniang Panlungsod has the power to "approve annual and supplemental budgets of the City Government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants";

WHEREAS, the City Mayor, Hon. Jefferson P. Soriano, has endorsed a request for an Appropriation Ordinance through a Supplemental Budget in the amount of Sixty One Million Pesos (P61,000,000.00) for the payment of Personal Services, Maintenance and Other Operating Expenses and Capital Outlay;

WHEREAS, the Local Finance Committee submitted a certification as to the availability of funds from the Excess of the Retained Earnings for Calendar Year 2012 in the amount of Twenty Four Million Pesos (P24,000,000.00) and Reprogramming of Various PPA's from 20% Development Fund Current Year 2013 in the amount of Eighteen Million Pesos (P18,000,000.00) and Continuing 20% Development Fund (previous years) in the amount of Nineteen Million Pesos (P19,000,000.00) which are free from any obligation and is available for appropriation;

NOW, THEREFORE, be it ordained in session assembled by the Sixth City Council to enact:

**SECTION 1. AUTHORIZATION**. The General Fund Supplemental Budget No. 02 of Tuguegarao City for Calendar Year 2013 with a total appropriation of Sixty One Million Pesos (P61,000,000.00) is hereby authorized to finance the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay.
