#### **APPROPRIATION ORDINANCE NO. 03-2013**

#### AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 03 OF TUGUEGARAO CITY FOR CY 2013

WHEREAS, Section 458 of Republic Act 7160, otherwise known as the Local Government Code of 1991, and Article 99 (2) (i) of the Rules and Regulations Implementing the Local Government Code of 1991 provides that the Sangguniang Panlungsod has the power to "approve annual and supplemental budgets of the City Government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants";

WHEREAS, the City Mayor, Hon. Jefferson P. Soriano, has endorsed a request for an Appropriation Ordinance through a Supplemental Budget in the amount of Twenty Six Million, Eight Hundred Thousand Pesos (P26,800,000.00) for the payment of Personal Services, Maintenance and Other Operating Expenses and Capital Outlay;

WHEREAS, the City Treasurer submitted a certification dated November 19, 2013 as to the availability of funds from the Increase in Collection for CY 2013 in the amount of Twenty Six Million, Eight Hundred Thousand Pesos (P26,800,000.00);

NOW, THEREFORE, be it ordained in session assembled by the Sixth City Council to enact:

**SECTION 1. AUTHORIZATION.** The General Fund Supplemental Budget No. 03 of Tuguegarao City for Calendar Year 2013 with a total appropriation of Twenty Six Million, Eight Hundred Thousand Pesos (P26,800,000.00) is hereby authorized to finance the Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay.

SECTION 2. SOURCE OF FUNDS. The Appropriation shall be sourced out from the Increase in Collection of 2013 in the amount of Twenty Six Million, Eight Hundred Thousand Pesos (P26,800,000.00), to wit:

SECTION 6. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

With nine (9) members present voting in favor and one (1) against, APPROPRIATION ORDINANCE NO. 03-2013 was APPROVED under suspended rules.
