CITY ORDINANCE NO. 01-2013

**AN ORDINANCE CREATING THE POSITION OF ONE (1) MEDICAL OFFICER III,
SG 18, FOR THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY**

WHEREAS, Section 458 of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that the Sangguniang Panlungsod has the power to determine the positions and corresponding compensation and benefits of officials and employees;

WHEREAS, in the exigency of service, in order to promote efficiency and an effective personnel force, there is a need to create a new position for the Local Government Unit of Tuguegarao City and provide funds therefor;

NOW THEREFORE, be it ordained by the Fifth City Council in session assembled to:

SECTION 1. TITLE. This Ordinance shall be known as; "An Ordinance Creating the Position of Medical Officer III, Salary Grade 18, for the Local Government Unit of Tuguegarao City".

SECTION 2. CREATION OF NEW POSITION. The position of Medical Officer III, Salary Grade 18, is hereby created and approved.

SECTION 3. All matters pertinent to recruitment and placement for the above created position shall be governed by the Civil Service Commission law, rules and regulations, and other related issuances.

SECTION 3. EFFECTIVITY. This Ordinance shall take effect upon its approval.

On motion of all members present, **CITY ORDINANCE NO. 01-2013** was UNANIMOUSLY APPROVED.


