**AN ORDINANCE INSTITUTIONALIZING THE GRANT OF BURIAL ASSISTANCE TO
INDIGENT SENIOR CITIZENS OF TUGUEGARAO CITY AND APPROPRIATING FUNDS
FOR THE PURPOSE**

that: **BE IT ENACTED** by the Sangguniang Panlungsod of Tuguegarao City in session assembled,

SECTION 1. DECLARATION OF THE POLICY. As provided in the Constitution of the Philippines- Article II on the Declaration of Principles and State Policies, Section 10, the State shall provide social justice in all phases of national development and pursuant to Section 4 (L) of R.A. 9994 also known as the "Expanded Senior Citizens Act of 2010", the State values the dignity of every human person ^{and} guarantees full respect for human rights.

SECTION 2. DEFINITION OF TERMS. For purposes of this Ordinance, the terms are defined as follows:

Senior Citizen refers to any Filipino citizen who is a resident of the Philippines and who is sixty (60) years old or above. It may apply to senior citizens with "dual citizenship" status provided they prove their Filipino citizenship and have at least six (6) months residency in Tuguegarao City.

Indigent Senior Citizen refers to one who prior to his/her death is without pension or regular source of income, compensation or financial assistance from his/her relatives to support his/her basic needs.

Beneficiary/Benefactor refers to any person whether related or not to the senior citizen who provides care or who gives any form of assistance to him/her, and on whom the senior citizen is dependent on for primary care and material support, as certified by the barangay captain where he/she resides and the City Social Welfare and Development Officer (CSWDO).

SECTION 3. QUALIFICATIONS. The Qualifications shall be in accordance with the following policies as prescribed by the Tuguegarao City Office for Senior Citizens Affairs. In Case of Death, the indigent Senior Citizen's legitimate beneficiary/benefactor concerned is entitled to Two Thousand (P2,000.00) Pesos burial Assistance with the following requirements, to wit:

- a. Certification from the barangay captain where the elderly resided for at least six (6) months;
- b. Certification from the corresponding Barangay Senior Citizens Association President as bonafide member of the Association;
- c. Photocopy of Death Certificate authenticated by the Civil Registrar of Tuguegarao City.
- d. An Affidavit of claimant executed by the legitimate beneficiary/benefactor.


SECTION 4. SOURCE OF FUNDS. The Office of the City Mayor shall appropriate an amount intended for the said purpose and such budget may be increased or augmented as recommended by the OSCA Head and/or the City Social Welfare Development Office of this City.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon approval.


On motion of all members present, **CITY ORDINANCE NO. 05-2013** was UNANIMOUSLY APPROVED.
