CITY RESOLUTION NO. 004-2013

A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY HONORABLE CITY MAYOR DELFIN T. TING WITH THE NATIONAL IRRIGATION ADMINISTRATION (NIA) REPRESENTED BY THE REGIONAL IRRIGATION MANAGER VICENTE E. GALVEZ, CESO V, FOR THE CONSTRUCTION OF PROTECTION WORKS AT BARANGAY LARION ALTO AND GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT

WHEREAS, Section 5 of Article XIII of the Philippine Constitution provides that: "The State shall recognize the right of farmers, farm workers, and landowners as well as cooperatives and other independent farmer's organizations to participate in the planning, organization and management of the program, and shall provide support to agriculture through appropriate technology and research and adequate financial, production, marketing and other support services";

WHEREAS, by virtue of the above-mentioned constitutional provision, the Department of Agriculture (DA) has set up the Balikatan Sagip Patubig Program (BSPP) as the very first of its kind in irrigation involving Irrigators' Association (IA), Local Government Unit (LGU) and National Government (thru D.A.) cost sharing scheme;

WHEREAS, the Program makes available some funds in the amount of Nine Million Six Hundred Sixty Four Thousand Four Hundred Sixty Nine Pesos and Forty Four Centavos (P9,664,469.44) for the rehabilitation of irrigation system to LGUs and Irrigators' Association which can put their corresponding guidelines on the availment of the BSPP Fund which include among others the coverage/scope, site identification and prioritization, financing and operation;

WHEREAS, the implementation of the rehabilitation of the irrigation system can be done through the collaboration of NIA, Local Government Unit and IA through an appropriate agreement;

WHEREAS, the NIA, in coordination with the LGU and farmer beneficiaries, has identified the priority recipient irrigation system;

WHEREAS, the NIA/LGU has presented that it has the capacity to prosecute and implement the construction of River Protection, subject to the aforesaid fund allocation;

WHEREAS, the Sangguniang Panlungsod through the Committee on Rules, Ethics, Justice and Human Rights as the lead committee and Committee on Agriculture, after reviewing the terms and conditions of the said Memorandum of Agreement, has found the same to be in order, necessary and beneficial to the best interest of the farmers of Tuguegarao City.

NOW THEREFORE, RESOLVED, as it is hereby RESOLVED, to approve the Memorandum of Agreement and the granting of authority to the Honorable City Mayor Delfin T. Ting to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the National Irrigation Administration.

On motion of Hon. Engelbert C. Caronan and without objection from the Body, CITY RESOLUTION NO. 004-2013 was UNANIMOUSLY APPROVED.
