CITY RESOLUTION NO. 006-2013

**A RESOLUTION REQUESTING THE HONORABLE RANDOLPH SERA TING
AS THE REPRESENTATIVE OF THE 3RD DISTRICT OF CAGAYAN
TO INITIATE THROUGH A LEGISLATIVE ACTION OR OTHER MEANS
THE CONVERSION OF BARANGAY ROADS OF CAGGAY, LARION BAJO,
CAPATAN AND LIBAG NORTE TO NATIONAL ROADS**

WHEREAS, Tuguegarao City has a population of 138,865 (2010 Census) and a 2.56% population growth rate (2007-2010 Census) and provides socio-economic, infrastructure and administrative services and facilities to the Provinces of Cagayan, Isabela, Nueva Vizcaya, Quirino, Batanes, Kalinga, Apayao, Ifugao and Ilocos Norte;

WHEREAS, the daytime population of Tuguegarao City could no longer be comfortably accommodated in the city's existing Central Business District and surrounding lower-level service centers, thus creating traffic congestion that results to loss of productive man hours and increased emission of greenhouse gases that exacerbates the city's thermal heat and escalates the adverse effects of climate change in the city and surrounding municipalities;

WHEREAS, in the City's desire to improve its adaptive capacity and resiliency and to create alternative routes to and from the city center, the Tuguegarao City Government constructed the 5.3 kilometer River Park Circumferential Road and the Caggay-Larion Bridge in support of the 2.4 kilometer Centro 09-Libag Norte Road and the Pinacanauan Overflow Bridge that could no longer adequately serve the continuously increasing traffic and pedestrian volume;

WHEREAS, to adequately serve the commuting needs of the influence area of Tuguegarao City well into the next 50 years, the barangay roads of Caggay, Larion Bajo, Capatan and Libag Norte connected to the Caggay-Larion Bridge and the Pinacanauan Overflow Bridge need to be upgraded into national roads;


WHEREAS, the Representative of the 3rd District of Cagayan in the person of Hon. Randolph Sera Ting may, through a legislative action or other means, cause the conversion of the said barangay roads into national roads.

NOW THEREFORE, RESOLVED, as it is hereby RESOLVED, to request the Hon. Randolph Sera Ting as the Representative of the 3rd District of Cagayan to initiate through a legislative action or other means the conversion of Barangay Roads of Caggay, Larion Bajo, Capatan and Libag Norte to national roads.


