CITY RESOLUTION NO. 020-2013

A RESOLUTION APPROVING THE ANNUAL BUDGET OF BARANGAY LINAO WEST FOR CY 2012

WHEREAS, the Sangguniang Panlungsod or Sangguniang Bayan is empowered to review all Barangay Ordinances authorizing annual/supplemental appropriations as mandated in Chapter III, Article 2, Section 333 of the Local Government Code of 1991;

WHEREAS, the Committee on Finance, Appropriations, Ways and Means reviewed the Annual Budget of Barangay Linao West for CY 2012;

WHEREAS, the Annual Budget of Barangay Linao West for CY 2012 complied with the established budgetary requirements as certified by the City Budget Officer and same was validated by the Committee on Finance, Appropriations, Ways and Means;
