## **CITY RESOLUTION NO. 024-2013**

## A RESOLUTION APPROVING THE RENEWAL OF A LEGISLATIVE FRANCHISE OF THE DUPAYA RECREATION CENTER, INC. TO OPERATE A COCKPIT IN TUGUEGARAO CITY FOR A PERIOD OF THREE (3) YEARS

WHEREAS, the Dupaya Recreation Center, Inc. with business address at Highway, Barangay Leonarda, Tuguegarao City is duly established corporate entity under the laws of the Republic of the Philippines;

WHEREAS, the Dupaya Recreation Center, Inc. has all the qualifications and none of the disqualifications to operate and maintain, for recreational and commercial purposes, a cockpit within Tuguegarao City, having complied with all the requirements of Ordinance No. 08-2005, otherwise known as "The Cockfighting Ordinance of 2005".

NOW THEREFORE, on motion of all members present:

RESOLVE, as it is hereby RESOLVED, to approve the renewal of a Legislative Franchise to the Dupaya Recreation Center, Inc. to Operate a Cockpit in Tuguegarao City, subject however, to strict compliance with the provisions of Ordinance No. 08-2005 and to the following conditions:

- 1. That the franchise shall be for a period of three (3) years from January 2013 to December 2015.
- 2. Payment of the franchise fee of One Hundred Fifty Thousand Pesos (P150,000.00).
- 3. To comply with the requirements under Resolution No. 005-2006 (Guidelines on the Implementation of the Cockfighting Ordinance).

- 4. That it shall operate on Sundays only starting 9:00 AM and shall end at 7:00 AM the following day without prejudice to the issuance of a special permit to hold derbies/pintakasis on said date and such other dates or holidays not exceeding three (3) days upon the payment of the requisite fees and charges, provided that such derby/pintakasi shall not go beyond 7:00 AM of Monday.
- That the management shall strictly comply with all the conditions and regulations provided for under Ordinance No. 08-2005, Local Revenue Code and other rules and regulations.

On motion of Hon. Eliseo B. Ave and without objection from the Body, CITY RESOLUTION NO. 024-2013 was UNANIMOUSLY APPROVED.
