CITY RESOLUTION NO. 026-2013

A RESOLUTION AUTHORIZING THE CITY MAYOR HONORABLE DELFIN T. TING, TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, REGIONAL FIELD OFFICE 02, FOR THE IMPLEMENTATION OF THE SUPPLEMENTARY FEEDING PROGRAM IN THE LGU DAY CARE CENTERS FOR CY 2013

WHEREAS, most recent data from the 7th National Nutrition Survey (2008) conducted by the Food and Nutrition Research Institute of the Department of Science and Technology indicated that prevalence of under and over nutrition still persists among Filipino children and has significantly increased as compared to the last survey;

WHEREAS, the Department of Social Welfare and Development mandated to provide social welfare and development programs particularly through technical assistance and resource augmentation is providing nutrition services to its clients at the local level through the center-based services in partnership with Non-Government Organizations under the Program Management Bureau, such as the Food for School and Healthy Start Feeding Program in the Day Care Centers which were previously implemented nutrition programs of the Department;

WHEREAS, though malnutrition among children is a problem that needs to be addressed by the government, children who are at-risk of malnutrition should also be given equal consideration to prevent them from becoming malnourished;

WHEREAS, the Sangguniang Panlungsod through the Committee on Social Welfare and Development and Committee on Health and Sanitation, after carefully reviewing the terms and conditions


of the said Memorandum of Agreement, has found the same to be in order, necessary and beneficial to the people of Tuguegarao City particularly the day care children.

NOW THEREFORE RESOLVED, as it is hereby RESOLVED, to authorize the City Mayor Honorable Delfin T. Ting to sign for and in behalf of the City Government of Tuguegarao the Memorandum of Agreement with the Department of Social Welfare and Development for the implementation of the Supplemental Feeding Program in the LGU Day Care Centers for CY 2013.


On motion of all members present, **CITY RESOLUTION NO. 026-2013** was UNANIMOUSLY APPROVED.
