**CITY RESOLUTION NO. 028-2013**

**A RESOLUTION RATIFYING THE FEES PRESCRIBED UNDER THE IMPLEMENTING RULES AND REGULATING REPUBLIC ACT 10172 OTHERWISE KNOWN AS “AN ACT FURTHER AUTHORIZING THE CITY OR MUNICIPAL CIVIL REGISTRAR OR THE CONSUL GENERAL TO CORRECT CLERICAL OR TYPOGRAPHICAL ERRORS IN THE DAY AND MONTH IN THE DATE OF BIRTH OR SEX OF A PERSON APPEARING IN THE CIVIL REGISTER WITHOUT THE NEED OF A JUDICIAL ORDER, AMENDING FOR THIS PURPOSE REPUBLIC ACT NUMBERED NINETY FORTY-EIGHT”**

WHEREAS, Republic Act No. 10172, otherwise known as “An Act Further Authorizing the City or Municipal Civil Registrar or the Consul General to Correct Clerical or Typographical Errors in the day and month in the date of birth or sex of a person appearing in the Civil Register without need of a Judicial Order”, was passed into law on August 15, 2012;

WHEREAS, Republic Act No. 10172 now authorizes the Local Civil Registrar to correct Clerical or Typographical Errors in the day and month in the date of birth or sex of a person without need of judicial order provided that the petitioner have complied with the requirements stated in the said law;

WHEREAS, it is stated under paragraph 6 of Rule 10 of the Implementing Rules and Regulation of RA 10172 that: “The local legislative body shall ratify the fees prescribed therein upon effectivity of the said Order, provided, however, that the fees prescribed therein shall be in uniform in all cities and municipalities in the country, and in all Philippine Consulates”;

WHEREAS, Section 10 of the Implementing Rules and Regulations of Republic Act No. 10172 states in part that:

- 1) The C/MCR is hereby authorized to collect from every petitioner Three Thousand Pesos (P3,000.00) for petition to correct the day and/or month in the date of birth or sex. An indigent petitioner shall be exempt from paying the required payment, provided that the petition is supported by a certification from the City/Municipal Social Welfare Office that the petitioner/document owner is indigent.
- 2) In the case of a petition filed with the Consul General, a filing fee of One Hundred Fifty U.S. dollars (\$150.00) or its equivalent value in local currency for the correction of clerical or typographical error is required.
- 3) In the case of a migrant petition, there shall be a service fee of One Thousand Pesos (P1,000.00) to be collected by the PRCR.
- 4) When a petitioner/document owner files petition for correction of clerical error under R.A. 9048, simultaneously, with a petition for correction of clerical error under R.A. 10172, and the same document is involved, the petitioner/document owner shall pay only the amount of P3,000.00 corresponding to the fee under R.A. 10172.

NOW THEREFORE RESOLVE, as it is hereby RESOLVED, to adopt fees prescribed under Rule 10 of the Implementing Rules and Regulations of RA 10172 and to authorize the Local Civil Registrar to collect the appropriate fees under the said law.

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the Office of the Local Civil Registrar for their information.

On motion of all members present, **CITY RESOLUTION NO. 028-2013** was UNANIMOUSLY APPROVED.


