**A RESOLUTION AUTHORIZING THE CITY MAYOR HONORABLE DELFIN T. TING,  
 TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE  
 TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT OF SOCIAL WELFARE  
 AND DEVELOPMENT, REGIONAL FIELD OFFICE 02,  
 FOR THE REPLICATION OF THE:**

- 1. USE OF THE MODIFIED SOCIAL STRESS MODEL (MSSM) IN MANAGING CHILDREN IN NEED OF SPECIAL PROTECTION**
- 2. SPECIAL DRUG EDUCATION PROGRAM (SDEC)**
- 3. FAMILY DRUG ABUSE AND PREVENTION PROGRAM (FDAPP)**
- 4. SHELTERED WORKSHOP FOR OLDER PERSON AND PERSON WITH DISABILITY**

WHEREAS, the Department of Social Welfare and Development, developed the projects entitled: Use of the Modified Social Stress Model (MSSM) in Managing Children in Need of Special Protection, Special Drug Education Program (SDEC), Family Drug Abuse and Prevention Program (FDAPP), Sheltered Workshop for Older Person and Person with Disability in the city as a response to the rising incidence of the vulnerable sectors;

WHEREAS, the Sangguniang Panlungsod thru the Committee on Social Welfare and Development, after carefully reviewing the terms and conditions of the said Memorandum of Agreement has found the same to be in order, necessary and beneficial to the people of Tuguegarao City.


