CITY RESOLUTION NO. 031-2013

A RESOLUTION APPROVING THE CITY DISASTER RISK REDUCTION AND MANAGEMENT FINANCIAL PLAN FOR CY 2013

WHEREAS, Republic Act No. 10121, otherwise known as, An Act Strengthening the Philippine Disaster Risk Reduction and Management System, providing for the national disaster risk reduction and management framework, and institutionalizing the national disaster risk reduction and management plan, appropriating funds therefor and for other purposes, mandates the creation of the Local Disaster Risk Reduction Management Council (LDRRM) and the City Disaster Risk Reduction Management (CDRRM) Office;

WHEREAS, the Honorable City Mayor has endorsed CDRRM Resolution No. 04, series of 2012, a Resolution requesting the approval of the CY 2013-2015 City Disaster Risk Reduction and Management Work Plan and CY 2013 City Disaster Risk Reduction and Management Financial Plan;

WHEREAS, pursuant to Section 21 of RA 10121, the CDRRM Fund was created to address the city's needs for risk preparedness, mitigation, rehabilitation and recovery purposes;

WHEREAS, the CY 2013-2015 CDRRM Financial Plan has complied with the requirements of law;


WHEREAS, the amount of Twenty Five Million, Four Hundred Sixty Five Thousand, Five Hundred Fifty Six Pesos (P25,465,556.00) is available to implement the CDRRM Plans, such as but not limited to pre-disaster, preparedness program, prevention, reduction, mitigation and recovery.

WHEREFORE RESOLVE, as it is hereby RESOLVED, by the Sangguniang Panlungsod in session assembled, to approve the CY 2013 City Disaster Risk Reduction and Management Financial Plan.
