CITY RESOLUTION NO. 032-2013

A RESOLUTION ENCOURAGING ALL PUNONG BARANGAYS AND SANGGUNIANG BARANGAY MEMBERS IN THE CITY OF TUGUEGARAO, PURSUANT TO DILG MEMORANDUM CIRCULAR 2010-147, TO REAPPOINT BARANGAY HEALTH WORKERS (BHWs), BARANGAY NUTRITION SCHOLAR (BNS) AND BARANGAY DAY CARE WORKERS (BDCWs) WHO HAVE UNDERGONE SEMINARS AND TRAININGS AND GAINED SUFFICIENT EXPERIENCES IN THE PERFORMANCE OF THEIR RESPECTIVE JOBS

WHEREAS, the Barangay Health Workers (BHWs), Barangay Nutrition Scholar (BNS) and Barangay Day Care Workers (BDCWs) are the partners of the barangay government who perform the following duties and responsibilities, to wit: monitor health status, demonstrate and teach and give healthful information, deliver basic health services, listen and attend to the health concerns of the people living in that barangay:

WHEREAS, the Department of Interior and Local Government (DILG) issued Memorandum Circular No. 2010-147 on December 13, 2010 to all Punong Barangays, Sangguniang Barangay Members, DILG Regional Directors, the Regional Governor of the Autonomous Region in Muslim Mindanao and others concerned;

WHEREAS, the City Government of Tuguegarao supports DILG Memorandum Circular No. 2010-147 for the continuity and sustainability of the health status not to mention the time, money and effort saved in continuously utilizing their knowledge, skills and experiences in their field of services, thus avoiding the need to train a replacement;


WHEREAS, such strong encouragement for the implementation of Memorandum Circular No. 2010-147 by the city government, however, is not absolute and, therefore, subject to exception which the Punong Barangay and the Sangguniang Barangay Members may deem it right and proper.


On motion of all members present, **CITY RESOLUTION NO. 032-2013** was UNANIMOUSLY APPROVED.
