**A RESOLUTION APPROVING THE ANNUAL BUDGET OF

WHEREAS, the Annual Budget of Barangay Centro 07 for CY 2013 complied with the established budgetary requirements as certified by the City Budget Officer and same was validated by the Committee on Finance, Appropriations, Ways and Means;

RESOLVED FURTHER that all disbursements shall be in accordance with prescribed guidelines.


