**CITY RESOLUTION NO. 046-2013**

**A RESOLUTION APPROVING THE MEMORANDUM OF UNDERTAKING TO BE ENTERED INTO BY AND AMONG THE CITY GOVERNMENT OF TUGUEGARAO, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) RO2, MINES AND GEOSCIENCES BUREAU (MGB) RO2 AND ENVIRONMENTAL MANAGEMENT BUREAU (EMB) RO2 FOR THE CONDUCT OF AN ENVIRONMENTAL SUMMIT AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. JEFFERSON P. SORIANO TO SIGN THE SAID MEMORANDUM OF UNDERTAKING**

**WHEREAS**, pursuant to Article 1, Section 455 (vi) of the Local Government Code of 1991, the City Mayor represents the City in all its business transactions and signs in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or city ordinance;

**WHEREAS**, Section 26 of the Local Government of the Philippines states that "It shall be the duty of every agency or government-owned or controlled corporation authorizing or involved in the planning and implementation of any project or program that may cause pollution, climatic change, depletion of non-renewable resources, loss of crop land, rangeland, or forest cover, and extinction of animal or plant species, to consult with local government units, non-governmental organizations, and other sectors concerned and explain the goals and objectives of the project or program, its impact upon the people and the community in terms of environmental or ecological balance, and the measures that will be undertaken to prevent or minimize the adverse effects thereof."

**WHEREAS**, the City Government of Tuguegarao, the Department of Environment and Natural Resources (DENR) RO2, the Mines and Geosciences Bureau (MGB) RO2 and the Environmental Management Bureau (EMB) RO2 are scheduled to host an Environmental Summit on 26 July 2013;

**WHEREAS**, the aforementioned government agencies have agreed to contribute their financial, technical and logistical capabilities for the said undertaking through a Memorandum of Undertaking;

**WHEREAS**, Section 8, paragraph B, 1, (f) of R.A. 8755 otherwise known as the Charter of Tuguegarao City provides that the City Mayor shall “represent the City in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents with authority from the Sangguniang Panlungsod or pursuant to law or ordinance”;

**NOW THEREFORE**, be it **RESOLVED**, as it is hereby **RESOLVED**, by the City Council of Tuguegarao, Cagayan, Philippines, by virtue of the powers vested in it by law, in session assembled;

**RESOLVED**, that the Memorandum of Undertaking to be entered into by and among the City Government of Tuguegarao, Department of Environment and Natural Resources RO2, Mines and Geosciences Bureau RO2 and Environmental Management Bureau RO2 be adopted for the conduct of the Environmental Summit.


**RESOLVED FURTHER**, that Tuguegarao City is hereby authorized to enter into a Memorandum of Undertaking with the Department of Environment and Natural Resources RO2, Mines and Geosciences Bureau RO2 and Environmental Management Bureau RO2 for the conduct of an Environmental Summit.

**RESOLVED FINALLY**, that the City Mayor, Atty. Jefferson P. Soriano, shall be authorized to sign for and in behalf of Tuguegarao City the Memorandum of Undertaking with the Department of Environment and Natural Resources RO2, Mines and Geosciences Bureau RO2 and Environmental Management Bureau RO2, subject to all legal and existing rules and regulations for the conduct of Environmental Summit.


On motion of all members present, **CITY RESOLUTION NO. 046-2013** was **UNANIMOUSLY APPROVED**.
