CITY RESOLUTION NO. 056-2013

**A RESOLUTION APPROVING THE CONDUCT OF THE "PRESYO AGAWID" AND
AUTHORIZING THE CITY MAYOR TO NEGOTIATE WITH QUALIFIED OPERATORS**

WHEREAS, the traditional celebration of the Patronal Feast of Tuguegarao is highlighted by the "Presyo Agawid" flea market activity along the streets surrounding the Tuguegarao Central Market from August 1 to September 15 annually;

WHEREAS, pursuant to Committee Report No. 020-2013, the Committee on Trade, Commerce, Industry and Cooperatives, Committee on Ways and Means and the Committee on Public Order, Safety and Disaster Preparedness favorably recommend the passage of a Resolution approving the conduct of the Presyo Agawid and authorizing the City Mayor, Hon. Jefferson P. Soriano, to negotiate with qualified operators subject to the following conditions:

1. For the operator to secure a Mayor's permit;
2. Installation and dismantling of stalls be done by the operator;
3. Electric and water bills shall be borne by the operator;
4. Maintenance of cleanliness and sanitation within the premises;
5. Re-routing of traffic flow to ensure orderliness;
6. Prohibition in the use of flammable materials such as LPG and firewood;
7. A fire truck should always be available at the vicinity;
8. No extension of time to operate will be allowed; and,
9. Not lower than One Million Seven Hundred Pesos (P1,700,000.00) contract price shall be paid in cash to the City Government before the contract signing.

WHEREAS, there is a necessity for the Office of the City Mayor to negotiate with qualified operators for the conduct of the said activity under such terms and conditions most advantageous to the City Government of Tuguegarao.

NOW THEREFORE RESOLVED, as it is hereby **RESOLVED**, to approve the conduct of the "Presyo Agawid" from August 1, 2013 to September 15, 2013 and hereby granting authority to the City Mayor, Hon. Jefferson P. Soriano, to negotiate with interested and qualified operators on such terms and conditions most favorable to the City Government.


