**A RESOLUTION ACCREDITING TWENTY SIX (26) CIVIL SOCIETY
ORGANIZATIONS BASED IN TUGUEGARAO CITY
PURSUANT TO DILG MC NO. 2013-70**

WHEREAS, the Department of Interior and Local Government (DILG) issued Memorandum Circular (MC) 2013-70 to reiterate the provisions of the Local Government Code relative to the accreditation of civil society organizations, and in the selection of representatives to the local special bodies to strengthen their participation in local governance and development processes;

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City reserves the right to revoke and/or cancel the accreditation in the event that they fail to comply with their undertakings or for any violation of existing laws, rules and regulations;

NOW THEREFORE RESOLVED as it is hereby **RESOLVED**, to accredit the twenty six (26) Civil Society Organizations based in Tuguegarao City pursuant to DILG MC 2013-70 to entitle them with the prerogatives and privileges stated therein;

RESOLVED FURTHER, that a copy of this Resolution be given to the accredited organizations for their information.
