WHEREAS, the City Mayor has endorsed CDC Resolution No. 01-2013 endorsing the priority projects for the 2nd Supplemental Budget for CY 2013 of Tuguegarao City;

WHEREAS, certain projects need additional funding for full completion, efficiency and effectiveness of City Government programs, services and facilities;

WHEREAS, the City Budget Officer issued the Statement of Balance of Appropriation as of August 31, 2013 with a total amount of Sixty One Million Pesos (P61,000,000.00) which is free from any obligation and available for appropriation.
