WHEREAS, Kindergarten has been mandated as integral part of the basic education system in the Philippines pursuant to Republic Act No. 10157, otherwise known as the "Kindergarten Education Act" of 2011, in consonance with the Millennium Development Goals on achieving Education for All (EFA) by the Year 2015 which aims to provide equal opportunities for all children to avail of accessible mandatory and compulsory kindergarten education that effectively promotes physical, social, intellectual, emotional and skills stimulation and values formation to sufficiently prepare them for formal elementary education;

WHEREAS, the Tuguegarao City Schools Division Superintendent has certified a number of volunteer kindergarten teachers in the four (4) School Districts of the City as per Division Summary Report on Kindergarten Volunteer Program for SY 2013-2014;

WHEREAS, under the Policies and Guidelines on the Implementation of the universal Kindergarten Education Program, the regular kindergarten teachers with permanent items are provided with funding allocation from the General Appropriations Act (GAA); however, the volunteer kindergarten teachers who possess the same qualifications and perform the same duties and responsibilities are extended merely minimal amount of honorarium released on staggered basis per semester;

WHEREAS, there is an imperative need to compensate the efforts and sacrifices of the City's Public School Volunteer Kindergarten Teachers through the grant of honorarium to augment the minimal honorarium.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to request the City Mayor to earmark and grant honorarium in the amount of TWO THOUSAND PESOS (P2,000.00) per month for the Public School Volunteer Kindergarten Teachers assigned in the four (4) School Districts in the City Division Schools of Tuguegarao City until such time that they will be given permanent items.


On motion of all members present, **CITY RESOLUTION NO. 075-2013** was UNANIMOUSLY APPROVED.
