A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE REGIONAL OFFICE NO. 02 REGARDING THE EL NINO 2010 BUREAU OF SOIL AND WATER MANAGEMENT (BSWM) FUND

WHEREAS, R.A. 8435 otherwise known as the Agriculture and Fisheries Modernization Act (AFMA) envisions to strengthen the agriculture and fisheries sector through modernization to attain food security, poverty alleviation, income enhancement and profitability, global competitiveness and sustainability;

WHEREAS, one of the interventions of the Department of Agriculture Regional field Office No.02 under various programs is the provision of Small Scale Irrigation Projects(SSIPs) in rain fed areas and mitigate the effect of extended dry spell, drought and flooding;

WHEREAS, the City Local Government Unit (CLGU) has requested for the transfer without cost the borrowed irrigation pump sets and accessories in order for them to respond immediately in the event of El Nino phenomenon occurrence within their respective territorial jurisdiction;

WHEREAS, the Tuguegarao City Government shall take the lead role in the implementation of mitigating measures such as lending of pump sets and accessories to farmers and fisher folks in case of occurrence of El Nino phenomenon;

Soriano, to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Agriculture, Regional Office No. 02, represented by its Regional Executive Director Lucrecio R. Alviar, Jr., CESO III for the implementation of the El Nino 2010 BSWM Fund.
