**CITY RESOLUTION NO. 106-2013**

**A RESOLUTION GRANTING THE CITY MAYOR, HON. JEFFERSON P. SORIANO,  
THE AUTHORITY TO SIGN FOR AND IN BEHALF OF THE TUGUEGARAO CITY  
GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF  
SOCIAL WELFARE AND DEVELOPMENT RO2 RELATIVE TO THE SOCIAL PENSION  
FOR INDIGENT SENIOR CITIZENS OF TUGUEGARAO CITY**

**WHEREAS**, the Department of Social Welfare and Development (DSWD) Region 2 and the Local Government Units have a constitutional mandate to provide social welfare and development programs for the senior citizens of the community to elevate and improve the quality of their lives;

**WHEREAS**, one of the programs of the DSWD is to grant Social Pension to the Indigent Senior Citizens to augment their daily subsistence needs and other needs;

**WHEREAS**, in support to the herein-stated program of the DSWD, the Tuguegarao City Government shall provide technical assistance to the DSWD by fulfilling its duties and responsibilities indicated in the Memorandum of Agreement (MOA);

**WHEREAS**, the Sixth City Council through the Committees on Social Services, Finance and Appropriations, and Laws, Ordinances, Revisions and Legal Matters, after having thoroughly reviewed the terms and conditions indicated in the MOA, the same was revised to reflect the true intent of the contracting parties;


**WHEREAS**, after the revisions of the said MOA, the herein Committees found the same to be in order, favorable and beneficial to the senior citizens of Tuguegarao City;

**NOW THEREFORE RESOLVE**, as it is hereby resolved to grant the City Mayor, Hon. Jefferson P. Soriano, the authority to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Social Welfare and Development RO2 Relative to the Social Pension for Indigent Senior Citizens of Tuguegarao City.
