WHEREAS, the Local Government Code provides under Section 438 that *a sangguniang kabataan chairman shall, upon certification of his election by the COMELEC and during his tenure of office is elected pederasyon president, serve as an ex-officio member of the sangguniang panlalawigan, sangguniang panlungsod, and sangguniang bayan as the case may be, without need of further appointment;*

WHEREAS, with the above-stated mandate, Hon. Nadine Jerome A. Cabugos assumed her term as the ex-officio member of the Sangguniang Panlungsod of Tuguegarao in October 2010;

WHEREAS, during her incumbency, Hon. Cabugos was the Chair of the Committee on Youth and Sports Development and a member of the Committees on Tourism, Culture and Arts, Committee on Barangay Affairs and Civic Action, Committee on Public Service, Transportation, Communication and Franchise, Committee on Market and Slaughterhouse, Committee on Planning, Zoning and Land Use, Committee on Public Information and Committee on Human Rights;




On motion of all members present, **CITY RESOLUTION NO. 107-2013** was **UNANIMOUSLY APPROVED**.
