**A RESOLUTION APPROVING THE ANNUAL BUDGET OF  
BARANGAY DADDA FOR CY 2013**

**WHEREAS**, the Committee on Finance and Appropriation reviewed the Annual Budget of Barangay Dadda for CY 2013;

**WHEREAS**, the Annual Budget of Barangay Dadda for CY 2013 has complied with the established budgetary requirements as certified by the City Budget Officer and same was validated by the Committee on Finance and Appropriation;
