CITY RESOLUTION NO. 112-2013

A RESOLUTION AUTHORIZING HONORABLE CITY MAYOR ATTY. JEFFERSON P. SORIANO TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL FIELD OFFICE NO. 02 FOR THE CONSTRUCTION OF SENIOR CITIZEN CENTERS AND DAY CARE CENTERS WITHIN TUGUEGARAO CITY

WHEREAS, Republic Act 7876 or “An Act Establishing a Senior Citizens Center in all cities and municipalities in the Philippines, and appropriating Funds therefor”, provides that senior citizens centers are intended to be used as venues for the delivery of integrated and comprehensive social services to senior citizens and other members of the community;

WHEREAS, the Department of Social Welfare and Development, upon the requests from the Federation of Senior Citizens Association of the Philippines and Local Government Units (LGUs), shall extend financial assistance for the construction of Senior Citizens Center (SCCs) and Day Care Centers in their respective areas;

WHEREAS, pursuant to the Philippine Plan of Action for Children titled: The Filipino Children: 2000 and Beyond (Proc. No. 855), Day Care Centers for children and youth development shall be established in all local government units with special emphasis on primary care and protection of children;

WHEREAS, under the Bases Conversion Development Authority (BCDA), the Department of Social Welfare and Development (DSWD), in its mandate to provide social welfare and development programs particularly through technical assistance and resource augmentation, shall provide funding support to the Federation through the local government unit of Tuguegarao City for the construction of Senior Citizens Centers and Day Care Centers.

NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor, Atty. Jefferson P. Soriano, to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Social Welfare and Development Regional Field Office No. 02, represented by its Regional Executive Director Violeta A. Cruz, regarding the construction of Senior Citizen Center and Day Care Center.


On motion of all members present, **CITY RESOLUTION NO. 112-2013** was UNANIMOUSLY APPROVED.
