**CITY ORDINANCE NO. 018-2014**

**AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO USE SAVINGS FOR AUGMENTATION IN THE ANNUAL BUDGET FY 2014 IN ACCORDANCE WITH SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991**

**WHEREAS**, Section 336 of the Local Government Code of 1991 provides that the Local Chief Executive or the Presiding Officer of the Sanggunian is authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;

**WHEREAS**, the Local Chief Executive made a request for the use of savings for augmentation under his Maintenance and Other Operating Expenses (MOOE) for FY 2014;

**WHEREAS**, there is a need to allocate or provide funds for the payment of services rendered of job order workers and provide financial assistance for the conduct of the Tuguegarao City Athletic Association Meet (SY 2014-2015);

**WHEREAS**, it is necessary to authorize the use of savings for augmentation in accordance with Section 336 of the Local Government Code of 1991 for said purpose.



NOW THEREFORE, be it **ORDAINED** in Regular Session assembled:

**SECTION 1. USE OF SAVINGS AND AUGMENTATION.** The use of savings under the Maintenance and Other Operating Expenses (MOOE) of the City Mayor in the Annual Budget FY 2014 is hereby authorized for augmentation of funds in the amount of P5,450,000.00 for the following:

- 1.1 Payment of services rendered of job order workers from November-December 2014 amounting to P3,450,000.00.
- 1.2 Financial Assistance for the conduct of the Tuguegarao City Athletic Association Meet SY 2014 amounting to P2,000,000.00.

**SECTION 2.** The payment of services rendered by job orders shall be based on the official list of Job Orders from the Human Resource Management Office (HRMO) and appointments of the workers. The financial assistance for the conduct of the Tuguegarao City Athletic Association Meet SY 2014 shall be in accordance with the Program of Work. All disbursements shall be in accordance with budget, accounting and auditing rules and regulations.


**SECTION 3. SEPARABILITY CLASE.** If any section or provision of the Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 4. EFFECTIVITY.** This Ordinance shall take effect immediately upon its approval.
