**CITY ORDINANCE NO. 003-2014**

**AN ORDINANCE GRANTING AUTHORITY TO THE CITY MAYOR TO ENTER INTO A  
CONTRACT, MEMORANDUM OF AGREEMENT OR MEMORANDUM OF  
UNDERSTANDING WITH RADIO, TELEVISION AND PRINT MEDIA FOR AND ON  
BEHALF OF THE CITY GOVERNMENT OF TUGUEGARAO**

**WHEREAS**, Section 456 of the Local Government Code of 1991 on the Powers, Duties and Compensation states that the City Mayor can exercise other powers and perform other duties and functions as may be prescribed by law or ordinance;

**WHEREAS**, it is imperative for the City Mayor to enter into an agreement with radio, television and print media for information dissemination and to foster closer relationship and open communication with the community through the various media;

**WHEREAS**, the funds to be utilized for these Contracts, Memoranda of Agreement or Memoranda of Understanding shall come from the appropriations of the Office of the City Mayor;

**WHEREAS**, for these reasons, there is a need to grant authority to the City Mayor to enter into a Contract, Memoranda of Agreement and Memorandum of Understanding with media entities;

**RESOLVE**, as it is hereby **RESOLVED**, by the Sangguniang Panlungsod of Tuguegarao to grant authority to the City Mayor to enter into a Contract, Memoranda of Agreement and Memorandum of Understanding for and on behalf of the City Government.

**NOW, THEREFORE**, be it ordained by the Sangguniang Panlungsod of Tuguegarao in session assembled, to enact:

**SECTION 1. TITLE.** This Ordinance shall be known as the Ordinance Granting Authority to the City Mayor to enter into a Contract, Memoranda of Agreement or Memorandum of Understanding with radio, television and print media for and on behalf of the City Government of Tuguegarao.

**SECTION 2. DEFINITION OF TERMS.** As used and referred to in this Ordinance, the following terms shall mean:

1. Memorandum of Understanding – a document that expresses mutual accord on an issue between two or more parties.
2. Memorandum of Agreement or Cooperative Agreement – a document written between parties to cooperate on an agreed objective. It is generally more binding between the parties than the memorandum of understanding.
3. Contract – a meeting of minds between two persons whereby one binds himself, with respect to the other, to give something or to render something (Civil Code of the Philippines). It has the force and effect of law between the parties including third persons.
4. Agency – any business or organization established to provide a particular service, typically one that involves organizing transaction between two parties.
5. Establishment – an economic unit that produces and/or sells goods and services and operates from a single physical location.
6. Entity – any person, partnership, organization or business that has separately identifiable existence.

**SECTION 3. AUTHORITY.** The City Mayor is hereby granted the authority to enter into Contracts, Memoranda of Agreement or Memorandum of Understanding with radio, television and print media for and on behalf of the City Government of Tuguegarao.

**SECTION 4. RESTRICTIONS.**


1. The disbursements of funds shall be subject to the usual accounting, budgeting and auditing rules and procedures.
2. Only the City Mayor may enter into Contracts, Memoranda of Agreement or Memorandum of Understanding with radio, television and print media.

**SECTION 5. EFFECTIVITY.** This Ordinance shall take effect immediately upon its approval.






