CITY ORDINANCE NO. 005-2014

**AN ORDINANCE CREATING THE POSITION OF PROJECT EVALUATION OFFICER II
FOR THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY
AND PROVIDING FUNDS THEREFOR**

WHEREAS, Section 76 of R.A. 7160, otherwise known as the Local Government Code of 1991, empowers every local government unit to design and implement its own organizational structure and staffing pattern that will effectively address its respective development plans, programs, objective and priorities;

WHEREAS, the creation of the new position will augment manpower in the City Planning and Development Office and improve the delivery of basic services particularly those which have to do with the programs and projects which the City Mayor is empowered to implement and which the Sanggunian is empowered to provide for under the Local Government Code of 1991;

WHEREAS, in the exigency of service and in order to promote efficiency and an effective personnel force, there is a need to create a new position for the Local Government Unit of Tuguegarao City and provide funds therefor.

NOW THEREFORE, be it **ORDAINED** by the Sixth City Council in session assembled to enact:

SECTION 1. TITLE. This Ordinance shall be known as the "Ordinance Creating the Position of Project Evaluation Officer II for the Local Government Unit of Tuguegarao City and Providing Funds Therefor."

SECTION 2. CREATION OF THE NEW POSITION. There is hereby created the position of Project Evaluation Officer II, Salary Grade 15.

SECTION 3. FUNDING FOR THE NEW POSITION. The corresponding fund for the salary and other emoluments and benefits for the above stated position shall be provided in the next Supplemental Budget of Tuguegarao City and in its succeeding Annual Budgets.


SECTION 4. QUALIFICATIONS. All matters pertinent to recruitment and placement for the above created position shall be governed by civil service rules and regulations, and other related issuances.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect upon its approval.


On motion of Hon. Noel A. Mora and without objection from the Body, **CITY ORDINANCE NO. 005-2014** was **UNANIMOUSLY APPROVED** under suspended rules.


