CITY ORDINANCE NO. 011-2014

**AN ORDINANCE REQUIRING RESTAURANTS, CANTEENS, CAFETERIAS, FAST FOOD
CHAINS, CATERERS AND OTHER RELATED FOOD SERVICES
TO INCLUDE HALF RICE IN THEIR MENU LIST**

WHEREAS, Proclamation No. 494 Series of 2012 declared 2013 as the National Year of Rice to promote responsible consumption of rice and to achieve food security and self-sufficiency of rice and other food staples;

WHEREAS, the data of the Food and Nutrition Research Institute show that Filipinos waste an average of two tablespoons of cooked rice or nine grams of uncooked rice daily;

WHEREAS, study shows that the availability of half cup rice servings would minimize wastage of rice in the food service industry;

WHEREAS, in accordance with Section 16 of the Republic Act 7160, the local legislative body of the Local Government Unit shall enact ordinances that improve public morals and enhance economic prosperity.



NOW THEREFORE, be it **ORDAINED** by the 6th City Council of Tuguegarao in session **ASSEMBLED** to enact:

CHAPTER 1

SHORT TITLE

SECTION 1. SHORT TITLE. – This ordinance shall be known and cited as the **“TUGUEGARAO CITY ANTI- RICE WASTAGE ORDINANCE OF 2014.”**

CHAPTER 2

SCOPE AND COVERAGE

SECTION 2. SCOPE AND COVERAGE. This Ordinance shall apply to food service industries covering all business institutions responsible for any meal prepared outside the home such as restaurants, canteens, cafeterias, fast food chains, caterers and other related food services operating within the territorial jurisdiction of Tuguegarao City.

CHAPTER 3

DEFINITION OF TERMS

SECTION 3. DEFINITION OF TERMS. – When used under this Ordinance, the following terms and phrases shall mean as follows:

- a. **FOOD SERVICE INDUSTRY** - shall refer to businesses, institutions and companies responsible for any meal prepared outside the home such as restaurants, canteens, cafeterias, fast food chains and caterers.
- b. **HALF-RICE** – shall refer to the one-half of the regular serving of rice (half cup) offered by the food service industry.

CHAPTER 4

IMPLEMENTATION

SECTION 4. IMPLEMENTATION

4.1. Food service industries are hereby required to include one-half cup of cooked rice in their regular menu.

4.2. All food service industries are required to post a “2 x 3” poster/billboard of the Panatang Makapalay of the Department of Agriculture in a conspicuous place inside the establishment.

4.3. The City Agriculture Office and the City Health Office shall conduct a regular inspection to said food service industries to ensure the proper implementation of the provisions of this ordinance.

CHAPTER 5

PENALTIES

SECTION 5. PENALTIES – Any food service provider found violating this ordinance shall be penalized as follows

1st Offense – a fine of Three Hundred Pesos (P300.00) shall be imposed.

2nd Offense – a fine of Five Hundred Pesos (P 500.00) shall be imposed.



3rd Offense and Succeeding Offenses – a fine of Seven Hundred Pesos (P 700.00) shall be imposed.

CHAPTER 6

FINAL PROVISIONS

SECTION 6. SEPARABILITY CLAUSE. – The provisions of this Code are hereby declared to be separable and in the event that one or more of the other provisions are held illegal or unconstitutional, the validity of the other provisions shall not be affected.

SECTION 7. REPEALING CLAUSE. – Ordinances, executive orders and other local legislations inconsistent with this Ordinance are hereby modified or repealed accordingly.

SECTION 8. EFFECTIVITY. – This Ordinance shall take effect immediately upon its approval and in accordance with the provisions of the Local Government Code of 1991.


On motion of Hon. Rosauro G. Resuello and without objection from the Body, **CITY ORDINANCE NO. 011-2014** was UNANIMOUSLY APPROVED in plenary under suspended rules.

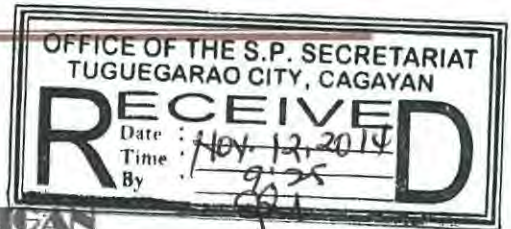




