CITY ORDINANCE NO. 016-2014

**AN ORDINANCE CREATING THE POSITION OF ONE (1) COMPUTER OPERATOR III,
SALARY GRADE 12 FOR THE OFFICE OF THE CITY VICE MAYOR
AND PROVIDING FUNDS THEREFOR**

WHEREAS, Section 76 of RA 7160, otherwise known as the Local Government Code of 1991, empowers local government units (LGUs) to design and implement their own organizational structure and staffing pattern which will effectively address their respective developmental plans, programs, objectives and priorities;

WHEREAS, the creation of the position of Computer Operator III will augment manpower in the City Vice Mayor's Office as well as the Office of the Sangguniang Panlungsod and improve the delivery of basic services particularly those which have to do with the programs and projects related to the legislative process which the City Mayor is empowered to implement and which the Sanggunian is empowered to provide for under the 1991 New Local Government Code;

WHEREAS, in the exigency of service and in order to promote efficiency and effective personnel force, there is a need to create a new position for the City Vice Mayor's Office of Tuguegarao City and provide funds therefor;

NOW, THEREFORE, be it **ORDAINED** by the Sixth City Council in session duly assembled to enact:

SECTION 1. TITLE. This Ordinance shall be known as the "Ordinance Creating the Position of One (1) Computer Operator III for the City Vice Mayor's Office of Tuguegarao City and Providing Funds Therefor."

SECTION 2. CREATION OF NEW POSITION. There is hereby created the position of one (1) Computer Operator III, Salary Grade 12.

SECTION 3. FUNDING FOR THE NEW POSITION. The corresponding fund for the salary grade and other emoluments and benefits for the above stated position shall be included as a priority item for appropriation in the Annual Budget of 2015 and in the succeeding Annual Budgets of the City.

SECTION 4. QUALIFICATIONS. All matters pertinent to recruitment and placement for the above created position shall be governed by the civil service laws, rules and regulations, and other related issuances.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect upon its approval.

COMMITTEE REPORT

SUBJECT:

TUGUEGARAO, CAGAYAN: CITY ORDINANCE NO. 016-2014 entitled: "AN ORDINANCE CREATING THE POSITION OF ONE (1) COMPUTER OPERATOR III, SALARY GRADE 12 FOR THE OFFICE OF THE CITY VICE MAYOR AND PROVIDING FUNDS THEREFOR"

FINDINGS:

Before this Committee is an ordinance that aims to create the position of Computer Operator III for the Office of the City Vice Mayor.

The Committee recognizes that the City of Tuguegarao is authorized by law to create such position according to its needs. As aptly mentioned in the ordinance, Section 76 of The Local Government Code in relation to Section 458 thereof specifically empowers the Sanggunian to "*design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission*".

However, a closer perusal of the subject Ordinance reveals that the specific appropriation needed to operationalize the creation of position is yet to be included in the 2015 Budget which is still pending before the Sanggunian Panlungsod. Hence, until then the position is to be considered an improperly created one, albeit, not necessarily invalid.

Moreover, this Committee observed that the Ordinance did not include the minimum qualification standard for the position. For purposes of clarity and by way of refinement, the Sanggunian Panlungsod is advised to include the relevant Quality Standards.

All told, this Committee affixes its approbation thereon subject to the foregoing discussions.

RECOMMENDATIONS:

WHEREFORE, this Committee hereby recommends the APPROVAL of CITY ORDINANCE NO.16 SERIES OF 2014 OF TUGUEGARAO CITY entitled: "AN ORDINANCE CREATING THE POSITION OF ONE (1) COMPUTER OPERATOR III, SALARY GRADE 12 FOR THE OFFICE OF THE CITY VICE MAYOR AND PROVIDING FUNDS THEREFOR".
