A RESOLUTION GRANTING AUTHORITY TO THE ACTING CITY MAYOR, ATTY. ENGELBERT C. CARONAN, JR., REPRESENTING THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT, REGION 02, REPRESENTED BY OIC-REGIONAL DIRECTOR MARLO L. IRINGAN, CESO V, FOR THE IMPLEMENTATION OF THE 2013 PERFORMANCE CHALLENGE FUND (PCF) IN THE AMOUNT OF THREE MILLION PESOS (P3,000,000.00) FOR THE ROAD CONCRETING OF BASSIG STREET (LECAROS STREET-LUNA STREET WITH A LENGTH OF 270.00 LN. M.) OF THE CITY OF TUGUEGARAO
