**CITY RESOLUTION NO. 007-2014**

**A RESOLUTION GRANTING THE ACTING CITY MAYOR, HON. ENGELBERT C. CARONAN, JR., AUTHORITY TO SIGN FOR AND IN BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE NATIONAL FOOD AUTHORITY FOR THE PURCHASE OF NFA RICE IN CASE OF CALAMITIES FOR RELIEF OPERATIONS PURPOSES**

**WHEREAS**, under the Local Government Code, provinces, cities and municipalities have been tasked with providing basic social services including relief assistance in times of calamities;

**WHEREAS**, the National Food Authority (NFA) is the government agency charged with among others, insuring the nation's adequate supply and distribution of grains;

**WHEREAS**, the Local Government Units (LGUs) are authorized to set aside an amount equivalent to 5% of their Internal Revenue Allotment (IRA) or any amount from their estimated revenue of unforeseen expenditures arising from the occurrence of calamities, provided that such appropriation shall be used only in the area affected by the calamities;

**WHEREAS**, in order to provide immediate assistance to its constituents, the City Government of Tuguegarao requested the National Food Authority for the purchase of rice on credit basis for relief program whenever a state of calamity is declared either by the local legislative bodies or the Office of the President;

**WHEREAS**, the Sixth City Council through the joint Committee of Public Order, Safety and Disaster Preparedness and Committee on Laws, Ordinances, Revisions and Legal Matters after having thoroughly reviewed the terms and conditions contained in the Memorandum of Agreement, the same is found to be in order, favorable and beneficial to the City Government of Tuguegarao.

**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to grant the Acting City Mayor, Hon. Engelbert C. Caronan, Jr., the authority to sign for and in behalf of the Tuguegarao City



Government the Memorandum of Agreement with the National Food Authority for the purchase of rice in case of calamities for relief operations purposes.

On motion of all members present, **CITY RESOLUTION NO. 007-2014** was UNANIMOUSLY APPROVED under suspended rules in plenary.
