THE SIXTH-MONTH SUSPENSION OF GV FLORIDA TRANSPORT, INC.**

WHEREAS, the GV Florida Transport, Inc. a duly enfranchised public utility passenger carrier with main provincial terminal in Tuguegarao City, Cagayan is the subject of a six (6) month Suspension Order issued by the Land Transportation and Franchising Regulatory Board (LTFRB) on account of the accident which caused the crash into a ravine of one of its buses last February 7, 2014 in Talubin, Bontoc, Mt. Province;

WHEREAS, the GV Florida Transport, Inc. which is undisputedly the dominant passenger carrier in Cagayan in particular and in Northern Luzon in general, has its main provincial terminal in

Tuguegarao City with branch terminals in Sampaloc, Manila, Cubao, Quezon City and plying routes to 43 key cities and towns of Cagayan;

WHEREAS, the cancellation of GV Florida's Franchise and six (6) months suspension of its operation will bring about great difficulties to daily commuters (students, traders, and especially common people) who depend mainly on land transportation in travelling from Tuguegarao to Manila and back commuting daily via the routes granted unto GV Florida, Inc., not to mention the concomitant harsh effects and hardships suffered not only by daily commuters but by the thousands of employees and their families who depend solely on the carrier for their subsistence.

NOW THEREFORE, on motion of Hon. Jude T. Bayona, duly seconded, be it:

RESOLVED, as it is hereby **RESOLVED**, for humanitarian consideration, to implore the Honorable Winston Ginez, LTFRB Chairman, to **RECONSIDER** its order imposing a six-month suspension on the operation of GV Florida Transport, Inc., for the general welfare of the riding public.

CITY RESOLUTION NO. 034-2014 was **UNANIMOUSLY APPROVED** under suspended rules.
