CITY RESOLUTION NO. 038-2014

**A RESOLUTION GRANTING AUTHORITY TO THE ACTING CITY MAYOR,
HON. ENGELBERT C. CARONAN, JR., TO SIGN FOR AND BEHALF
OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM
OF UNDERTAKING TO BE ENTERED INTO BY AND AMONG THE TUGUEGARAO CITY
GOVERNMENT, THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT
AUTHORITY (TESDA) AND THE APARRI POLYTECHNIC INSTITUTE (API)
FOR THE IMPLEMENTATION OF THE GRASSROOTS
PARTICIPATORY BUDGETING (GPB) PROGRAM**

WHEREAS, one of the objectives of the Tuguegarao City Government is poverty reduction attuned with the primary goal of the national government through countryside development;

WHEREAS, in line with the above objective, different programs and undertakings have been planned and implemented;

WHEREAS, TESDA-Cagayan and the City Government of Tuguegarao has allocated Four Hundred Thousand Pesos (P400,000.00) and One Hundred Thousand Pesos (P100,000.00), respectively, to finance needs-based skills training requirements of the community pursuant to the Grassroots Participatory Budgeting (GPB) Program of the government;

WHEREAS, the Aparri Polytechnic Institute (API) is serving as a TESDA training arm being a TESDA-administered school;

WHEREAS, the API, TESDA-Cagayan and the Tuguegarao City Government shall perform the undertakings stated in the Memorandum of Undertaking;

NOW, THEREFORE RESOLVE, as it is hereby **RESOLVED**, to authorize the Acting City Mayor, Hon. Engelbert C. Caronan, Jr., to sign for and in behalf of the Tuguegarao City Government the Memorandum of Undertaking to be entered into by and among the Tuguegarao City Government, the


Technical Education and Skills Development Authority (TESDA) and Aparri Polytechnic Institute (API) for the implementation of the Grassroots Participatory Budgeting (GPB) Program.

RESOLVED FURTHER, that a copy of this resolution be furnished to TESDA-Cagayan and API for their information.
