**CITY RESOLUTION NO. 049-2014**

**A RESOLUTION FAVORABLY ENDORSING TO THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS THE CONVERSION OF THE GONZAGA-CAPATAN ROAD CONNECTING CAGAYAN VALLEY ROAD AND CAGAYAN-APAYAO ROAD (TUGUEGARAO CITY SECTION) FROM A LOCAL ROAD TO A NATIONAL ROAD**

**WHEREAS**, under Executive Order No. 124, series of 1987, the Department of Public Works and Highways (DPWH) is mandated to “provide or authorize the conversion of roads and highways from one category to another;”

**WHEREAS**, the conversion of any local road requires a resolution from the City Council;

**WHEREAS**, there is a need to build a regular bridge over the troubled Capatan plains but the City Government does not have sufficient funds;

**WHEREAS**, City Mayor Jefferson P. Soriano has already initially conducted negotiations with the Regional Office II of the Department of Public Works and Highways (DPWH) for the latter to maintain said road using national government funds after its conversion and to include in their 2015 budget funding for the construction of the regular bridge to replace the overflow bridge;

**WHEREAS**, there is a need to convert said road into a national road to vest jurisdiction to DPWH so that it can finance and undertake the construction of the regular bridge and maintenance of said road;

**WHEREAS**, City Mayor Jefferson P. Soriano, in a letter dated 10 January 2014, requested for a Resolution from the Sixth City Council;

**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to favorably endorse to the Department of Public Works and Highways the Conversion of the Gonzaga-Capatan Road connecting


Cagayan Valley Road and Cagayan Apayao Road (Tuguegarao City Section) from a local road to a national road.

**RESOLVED FURTHER**, that a copy of this Resolution be forwarded to the Department of Public Works and Highways Regional Field Office No. 02 for proper action.

On motion of all members present, **CITY RESOLUTION NO. 049-2014** was UNANIMOUSLY APPROVED under suspended rules.
