WHEREAS, the Committee on Finance and Appropriation reviewed the Annual Budget of Barangay Buntun for CY 2014;

WHEREAS, the Annual Budget of Barangay Buntun for CY 2014 has complied with the established budgetary requirements as certified by the City Budget Officer and same was validated by the Committee on Finance and Appropriation;
