WHEREAS, among the competing student-athletes from the different regions, four students from Tuguegarao City have bagged silver and bronze medals; namely, Kimberly Melad who was a silver medalist in Taekwondo High School Division; Arriane Vallejo and Dominic Jose Careng who were silver medalists in Basketball Elementary Division; and Allan Rosario, Jr. who was a bronze medalist in Taekwondo Elementary Division;

WHEREAS, Kimberly Melad is a 4th year student of Cagayan National High School from Cataggaman Pardo, Tuguegarao City; Arriane Vallejo is a Grade VI pupil of St. Paul University Philippines from Ugac Sur, Tuguegarao City, Dominic Jose Careng is a Grade VI pupil of Tuguegarao West Central School from Barangay Caggay, Tuguegarao City and Allan Rosario, Jr. is a Grade VI pupil of Tuguegarao North Central School from Caritan Centro, Tuguegarao City;

WHEREAS, among the winning coaches are Miss Joanne Melad, coach of Taekwondo boys elementary division, who won 1 gold and bronze medals and Mrs. Maria Pagalilauan, coach of Taekwondo girls elementary division, who won 1 silver and bronze medals;

WHEREAS, Kimberly Melad, Arriane Vallejo, Dominic Jose Careng, Allan Rosario, Jr., Miss Joanne Melad and Mrs. Maria Pagalilauan have made Tuguegarao City proud by virtue of their achievements;
