**CITY RESOLUTION NO. 058-2014**

**A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND AMONG THE CLIMATE CHANGE COMMISSION, THE PROVINCIAL GOVERNMENT OF CAGAYAN, THE MUNICIPALITY OF ENRILE AND THE MUNICIPALITY OF IGUIG, CAGAYAN**

**WHEREAS**, the Tuguegarao City Government supports the national aim and objective of addressing vulnerability to climate change impacts in cities and to facilitate capacity building for local adaptation, planning, implementation and monitoring of climate change initiatives in vulnerable communities;

**WHEREAS**, the Climate Change Commission is further mandated to ensure the mainstreaming of climate change, in synergy with disaster risk reduction, into the national, sectoral and local development plans and programs;

**WHEREAS**, the Climate Change Commission, in partnership with the United Nations Development Programme (UNDP) and with funding support from the New Zealand Aid Programme (NZAP), is implementing the project titled "*Resilience Capacity Building for Cities and Municipalities to Reduce Disaster Risks from Climate Change and Natural Hazards, Phase I*" Project ReBUILD;

**WHEREAS**, on July 4, 2013, a Memorandum of Understanding between the Climate Change Commission and the Provincial Government of Cagayan was executed to jointly undertake activities under the project;

**WHEREAS**, Tuguegarao City, Enrile and Iguig are city/municipalities within the Cagayan River Basin in the Province of Cagayan which have been selected and agreed to be the pilot-LGUs for the project;


**NOW, THEREFORE,** for and in consideration of the foregoing premises:

**RESOLVE**, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor, Atty. Jefferson P. Soriano, to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement to be entered into by and among the Climate Change Commission represented by its Chairperson and Executive Director, Mary Ann Lucille L. Sering, the Provincial Government of Cagayan represented by the Honorable Governor, Atty. Alvaro T. Antonio, the Municipality of Enrile represented by the Honorable Mayor, Kim Stephen T. Turingan, and the Municipality of Iguig represented by the Honorable Mayor, Juditas L. Trinidad, for the implementation of the Project ReBUILD.


On motion of Hon. Noel A. Mora, duly seconded by Hon. Perla C. Tumaliuan and without objection from the Body, **CITY RESOLUTION NO. 058-2014** was **UNANIMOUSLY APPROVED** under suspended rules.
