**A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT AND
AUTHORIZING THE HONORABLE CITY MAYOR, ATTY. JEFFERSON P. SORIANO,
TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE
MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE
AND DEVELOPMENT REGARDING THE FOURTH CYCLE IMPLEMENTATION
OF THE SUPPLEMENTAL FEEDING PROGRAM**

WHEREAS, the Department of Social Welfare and Development, in its mandate to provide social welfare and development programs particularly through technical assistance and resource augmentation, is providing nutrition services to its clients at the local level through the center-based and community based services in partnership with non-government organizations under the Program Management Bureau such as Food for School and Healthy Feeding Program in day care centers which were previously implemented nutrition programs for the DSWD;

WHEREAS, Republic Act 69725, otherwise known as Barangay Level Total Development and Protection of Children Act, provides that "it is the policy of the state to defend the rights of children to assistance, including proper care and nutrition, and to provide them with special protection against all forms of neglect, abuse, cruelty, exploitation and other conditions prejudicial to their development";

WHEREAS, though malnutrition among children is a problem that needs to be addressed by the government, children who are at risk of malnutrition should also be given equal consideration to prevent them from becoming malnourished.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor, Atty. Jefferson P. Soriano, to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Social Welfare and Development Regional Office No. 02, represented by its Regional Executive Director Remia T. Tapispisan, regarding the implementation of the Fourth Cycle Supplemental Feeding Program.
