CITY RESOLUTION NO. 069-2014

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE CONTRACT OF LEASE WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION FOR THE USE OF A SPACE AT THE THIRD FLOOR OF THE CENTRAL PUBLIC MARKET TUGUEGARAO CITY

WHEREAS, the Philippine Health Insurance Corporation, a government owned and controlled corporation, duly registered, organized and existing by virtue of RA 78785 as amended by RA 9241 further amended by RA 10606 has formally requested to lease a portion of the third floor of the Central Public Market;

WHEREAS, the Tuguegarao City Government is the registered owner of the market stalls of the Central Public Market located at Tuguegarao City, Cagayan;

WHEREAS, the Sixth City Council, through the Committee on Laws, Ordinance, Revisions and Legal Matters studied the provisions stipulated in the Contract of Lease and made some amendments;

WHEREAS, the Committee found the terms and conditions beneficial to both parties;

WHEREAS, the PhilHealth is exempted from paying the "Goodwill" money since it is a service agency which will extend assistance to the constituents;

WHEREAS, the cost of initial improvement of the leased premises shall be equally borne by the Tuguegarao City Government and the Philippine Health Insurance Corporation.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor, Atty. Jefferson P. Soriano, to sign for and in behalf of the Tuguegarao City Government the Contract of Lease with the Philippine Health Insurance Corporation, represented by its Regional Vice

President, Mr. Oscar B. Abadu, Jr. for the use of a portion of the third floor of the Central Public Market located at Tuguegarao City, Cagayan.


With eleven (11) members voting in favor, none against and one (1) abstaining, **CITY RESOLUTION NO. 069-2014** was **APPROVED**.
