## **CITY RESOLUTION NO. 070-2014**

A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT AND AUTHORIZING THE HONORABLE CITY MAYOR, ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT REGARDING THE IMPLEMENTATION OF SKILLS REGISTRY SYSTEM

WHEREAS, the national government is committed to the organization, development and maximum utilization of the country's manpower resources;

WHEREAS, the Department of Labor and Employment (DOLE) is a government agency concerned with employment, promotion, regulation, stimulation and labor market information;

WHEREAS, the DOLE has embarked to undertake the establishment of Skills Registry System (SRS), a continuing nationwide manpower skills registration with the existing Phil-JobNet as the repository of the National Skills Registry System (NSRS);

WHEREAS, the NSRS is envisioned to enhance the data bank labor supply with manpower's corresponding skills and qualifications for ready access of Phil-JobNet registered business establishments and employment service clients;

WHEREAS, the Local Government Unit of Tuguegarao City, in coordination with the DOLE RO2, has established a Public Employment Service Office (PESO) in order to realize the objectives of the city government to deliver quality employment services to its constituents;

WHEREAS, the PESO Manager shall be needing relevant labor market information, specifically on the nature and qualifications of its available workforce, in order to effectively facilitate the employment of those currently unemployed and assist the business establishments in sourcing qualified manpower to fill their existing manpower requirements.



**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor, Atty. Jefferson P. Soriano, to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Labor and Employment, Regional Office No. 02, represented by its Regional Director Atty. Sixto T. Rodriguez, regarding the Skills Registry System.
