A RESOLUTION GRANTING ACCREDITATION TO THE SIERRA MADRE OUTDOOR CLUB AS A CIVIL SOCIETY ORGANIZATION PURSUANT TO THE PROVISION OF THE LOCAL GOVERNMENT CODE OF 1991 AND DILG MEMORANDUM CIRCULAR NO. 2007-81 DATED JULY 24, 2013

WHEREAS, the Sixth City Council through the Committee on Laws, Ordinances, Revisions and Legal Matters reviewed and deliberated on the merits of the application for accreditation of the Sierra Madre Outdoor Club (SMOC), a civil society organization based in Tuguegarao, pursuant to the Local Government Code of 1991 and DILG Circular No. 2013-17 dated July 17, 2007;

WHEREAS, the Committee found the application for accreditation of the SMOC with the necessary supporting documents to have complied with the requirements laid down by the Memorandum Circular and other standards set by the City Council.

NOW THEREFORE, for and in consideration of the foregoing premises,

RESOLVE, as it is hereby **RESOLVED**, to grant accreditation to the Sierra Madre Outdoor Club as a Civil Society Organization pursuant to the Local Government Code of 1991 and DILG Memorandum Circular No. 2013-17 to entitle it with the prerogatives and privileges stated therein;

RESOLVED FURTHER, to direct the above-mentioned organization to submit its audited financial statements to the Sangguniang Panlungsod to form part of its individual records.

RESOLVED FINALLY, that this Resolution be forwarded to the Office of the Honorable City Mayor, Atty. Jefferson P. Soriano, City Planning and Development Office and to the above stated accredited Civil Society Organization for their information and guidance.
